Report #1 on Continuing Professional Development | CPD Training Events

At the 70th Annual General Meeting of the Malaysian Bar ("AGM") on 19 Mar 2016, Members of the Bar adopted a resolution making the Continuing Professional Development ("CPD") Scheme mandatory for Members, to take effect on a staggered basis. With effect from 1 July 2016, Members of the Bar admitted as advocates and solicitors of the High Court of Malaya from 1 July 2011 onwards are required to obtain 16 CPD points for each 24-month CPD cycle, and pupils who commenced their pupillage from 1 July 2016 onwards are required to obtain eight CPD points in the course of their pupillage.

This is the first of a series of three reports on the progress of the mandatory CPD Scheme in the current CPD cycle, which runs from 1 July 2016 until 30 June 2018 ("CPD Cycle #3").

Number of CPD Activities and Participants

The table below contains data regarding the CPD training activities conducted, and the level of participation recorded, based on 989 out of 1,160 events during the first 18 months of CPD Cycle #3, ie from 1 July 2016 to 31 Dec 2017.

All the figures displayed below are based on data received from organisers and updated in our database, as at 25 Jan 2018.

Of the 1,160 events held between 1 July 2016 and 31 Dec 2017:

- (1) 207 events (ie 17.8%) were free of charge; and
- (2) 255 events (ie 21.9%) had fees of between RM10 and RM50 (excluding 6% GST) per participant.

As such, the fee for 462 of the 1,160 events (ie 39.8%) was RM50 or less.
