STREAMS

Corporate Law

Paper would focus on the changes that are taking place in the interaction between private law subjects in Contract, Tort, Unjust Enrichment, Equity and Trusts, Company Law, Competition Law, Taxation, Banking and Finance Law, Intellectual Property and various other related areas of law central to the parallel session themes.

Healthcare and Medical Law

Papers would revolve around the comprehensive examination of the role of law within the contemporary healthcare environment, laws relevant to aged community and related areas of law central to the parallel session themes.

Legal Education

The study to improve legal education and research techniques to enhance teaching and learning in law. Other aspects of education central to the parallel session themes are also welcome.

Human Rights and Liberties

The focus would be the study of changes in the regime of laws related to criminal offences, rights of citizens and non-citizens such as refugees, family law, employment law and International Human Rights central to the parallel session themes.

This list of topics is neither exhaustive nor exclusive: we encourage papers from diverse disciplines and research that employs a variety of methodologies. Contributions with an international comparative dimension based on sound empirical research are particularly welcome, as are papers that advance theories and concepts or propose innovative methodological approaches.
