Session 1: Best Interests of A Child: A Mystery!

**YA Dato' Faizah binti Jamaludin,
Shah Alam High Court Judge (NCVC 5)**



YA Dato' Faizah Jamaludin is a judge in the Shah Alam High Court. She served as a Judge of the Family Court in Kuala Lumpur from May 2019 to July 2020, and has written 38 judgments on various aspects of family law, including those relating to children.

YA Dato' Faizah currently represents the Malaysian Judiciary on the Council of ASEAN Chief Justices' ("CACJ") Working Group on Cross Border Disputes Involving Children ("CBDIC") set up to help families caught in cross-border disputes involving children within ASEAN. She has participated in the drafting of the CBDIC's "Common Procedures for Mediation, Code of Ethics for Mediators", and its common set of values, aspirations and principles for ASEAN judiciaries in disputes involving children.

YA Dato' Faizah is one of the advisory editors of the White Book – the Malaysian Civil Procedure 2021 and 2024. She was called to the English Bar in 1990 and the Malaysian Bar in 1994. She is an Overseas Bencher of the Inner Temple and is currently President of Malaysian Inner Temple Alumni Association ("MITAA").

**Judge Amy Alabado Avellano
Regional Trial Judge,
Supreme Court of the Philippines**



Judge Avellano is a family court judge and the executive judge in her jurisdiction. She is a professorial lecturer at the Philippine Judicial Academy and a founding member of HUKOM, Inc., which promotes judicial independence, integrity, and professionalism among Filipino trial court judges.

She focuses on family law, gender rights, juvenile justice, and judicial education. She holds degrees in mass communications (St. Theresa's College), law (University of San Carlos), and a Master of Laws (University of Minnesota, USA). She earned a post-graduate diploma in children, youth, and development from the Institute of Social Studies in The Hague, the Netherlands.

YA Puan Evrol Mariette Peters is currently a High Court Judge at the Family Court, Kuala Lumpur.

She started her legal career in 1992 after graduating from Universiti Malaya. After a couple of years in a law firm, she received a scholarship to complete her Master's degree at the Faculty of Law, Universiti Malaya.

After completing her LLM, she remained in academia, where she lectured and authored several articles and books, particularly in the law of evidence.

In 2002, she returned to legal practice as a legal associate, and then as partner in one of the largest firms in Kuala Lumpur.

After 15 years in the Kuala Lumpur law firm, in 2017, she continued her legal career in a Singaporean law firm as an associate director of its knowledge information and technology department.

She was appointed to the Judiciary in 2019, and in 2022 assumed her position at the Kuala Lumpur Family Court.

Foo Yet Ngo Partner, Y N Foo & Partners

Foo Yet Ngo has practised almost exclusively in the field of family law for over 40 years.



Foo began her legal career in a law firm in Kuala Lumpur with a general litigation practice. 13 years later, with a growing family law practice, Foo established Y N Foo & Partners, focusing entirely on family law, handling not only local family law cases but also multi-jurisdictional matrimonial disputes involving children and financial matters.

Foo was the first Malaysian to be invited to be a fellow IAFL, a worldwide association of practising family lawyers.

She was a Past President of the Association of Women Lawyers, an active member of the Bar Council Family Law Committee, and an inaugural member of the Malaysian Collaborative Practice Group ("MCPG").

Foo has represented clients in landmark Malaysian family law cases, appeared as *amicus curiae* in seminal Malaysian family law decisions and rendered her professional opinion on Malaysian family law to courts of foreign jurisdictions. She has contributed to several Malaysian and international legal publications on family law.

Goh Siu Lin Partner, Kee Sern, Siu & Huey

Siu Lin is a Bristol University graduate and a founding partner of Kee Sern, Siu & Huey. Siu Lin was the first woman Chairman of the Kuala Lumpur Bar and former President of the Association of Women Lawyers ("AWL"). She is currently the group leader of the International Academy of Collaborative Professionals ("IACP") Global Partners and the co-chair of the Malaysian MCPG. She is a trained collaborative law professional and accredited mediator. In 2022, she handled the first collaborative law case in Malaysia. She has since then handled several more cases using this process to assist families to divorce with integrity, dignity and mutual respect whilst prioritising their children's best interests.

Session 4: Hear Me Out – A Child's Voice in Family Matters

Dr Valerie Jacques
Founder, Integrated Psychology Network
Sdn Bhd



Dr Valerie is a consultant clinical psychologist and founder of Integrated Psychology Network Sdn Bhd for the past 26 years. Her clients include individuals and families from diverse cultures, across the world, living in Malaysia and around Asia. She works with couples from pre-marriage issues to marital conflicts, as well as support for those who have experienced the trauma of divorce and child custody.

Early in her career, she was active in the women's movement where in 1998 and 1999 she was invited to be a resource on the development of feminist counselling practice organised by Asia Pacific Forum on Women, Law and Development ("APWLD") in Seoul, South Korea, and Bali, Indonesia. In 2000, Valerie took a year off to be stationed in Bangladesh as an international expert on child counselling, working on a UNDP project to provide psychosocial support for street children. Her role included networking with both local and international organisations while looking into issues on government policy with the need to formulate strategies for implementation of child rights based on the United Nations Convention on the Rights of the Child.

Later in 2005, she worked as national psychologist for Medicin Sans Frontieres (Doctors without Borders) where she trained and supervised groups of volunteers for psychosocial and mental health support for survivors of crises and trauma, including migrants and refugees at outreach clinics as well as detention centres in Malaysia. In 2007, Dr Valerie was selected by the United Nations Department of Safety and Security to be trained and certified in critical incidents stress management ("CISM") for support in the Asia region.

She has guest lectured on gender diversity at Help University as well as at University Kebangsaan Malaysia's undergraduate course in forensic science on gender-based violence (domestic violence, rape, sexual harassment, and childhood sexual abuse) and Monash University on abnormal psychology. In 2010, she presented a paper on "Assessing the Assessor", an assessment of child custody in divorce cases at a conference organised by the Bar Council. In 2012, her study on the phenomenology of intrusive memories of a woman with childhood sexual trauma was published in the Non-Aligned Movement Institute for the Empowerment of Women ("NIEW") Journal under the Ministry of Women, Family and Development. She has presented on topics of parental alienation to the Bar Council and on shared parenting to the Fathers Rights Association in Malaysia.

Dr Valerie is a member of MCPG and a member of IACP as a family consultant in Malaysia. She was part of the team for the first collaborative case in Malaysia in 2022 and is committed to work that is in the best interest of children and families in two homes.

Session 7: Stop Hurting Me – Insight into the Mechanism for Victims of Domestic Violence

Senior Assistant Commissioner Siti Kamsiah Hassan, Principal Assistant Director, Sexual, Women and Children Investigation Division (D11), Bukit Aman



SAC Siti Kamsiah Hassan serves as the Principal Assistant Director of the Sexual, Women and Children Investigation Division (D11) of the Royal Malaysia Police in Bukit Aman. She has been in service since 1991 and has built a distinguished career in law enforcement relating to sexual crimes, and women's and children's issues. She holds an MBA from MAHSA University and has completed diplomas in investigation science and banking studies. Her extensive experience includes positions across several key divisions within the Royal Malaysia Police, where she has contributed significantly to investigations and management roles.

Prof Dato' Dr Noraida Endut is the past director of the Centre for Research on Women and Gender ("KANITA").
